Rules and Regulations

All films with max. 10 min can be submitted for the selection. Exceptions can be made.

Required information via E-mail include:

- Filled entry form
- 2 horizontal stills from the film (300dpi) as .jpg
- Recent portrait of the director (300dpi) as .jpg

The entry form has to be sent to the festival organizers of ISFF Detmold before the submission deadline, including the required materials and a preview copy. The film copies should be subtitled in English. Otherwise the submission will be not selected. It is also requested for German films.

The submissions will be selected by the organizers of the festival. All the decisions are final. Legal process is ruled out.

Your films should be send either via upload or via digital medium.

Accreditations can be applied for before the submission deadline. Upon request, we partially refund travel expenses and assist by organizing private accommodations.

Each author is responsible for the content of the work submitted and responsible for the acquisitions of the rights and explicitly exempts the organizer from possible legal recourse regarding unauthorized usage.
